- 7. If more than one of the joint holders be present at the Meeting personally or by proxy, that one of the said persons so present whose names stand first on the register of members of the Company in respect of the relevant shares shall also be entitled to vote in respect thereof.

To be valid, this form of proxy, together with the power of attorney or other authority, if any, under which it is signed or a notarially certified copy of that power or authority, must be deposited at the Company's share registrar and transfer office, Tricor Secretaries Limited, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong or via the designated URL (<a href="https://spot-emeeting.tricor.hk">https://spot-emeeting.tricor.hk</a>) by using the username and password provided on the notification letter sent by the Company as soon as possible but in any event not later than 48 hours before the time appointed for holding the Meeting (i.e. not later than 11:00 a.m. on Monday, 3 January 2022) or any adjournment thereof.
- 9. Completion and return of the form of proxy will not preclude you from attending and voting at the Meeting if you so wish.
- 10. References to time and dates in this instrument are to Hong Kong time and dates.
